### 2. Processing of Personal Data when visiting our Website

Personal Data refers to data, whether true or not, about an individual who can be identified directly from that data or indirectly from that data and other information to which an organisation has or is likely to have access (e.g. name, work address, function, title, e-mail address, phone/mobile number and account details) (collectively referred to as "Personal Data").

When you browse our Website for information purposes (i.e. when you do not register an account or otherwise submit any information to us), we collect your usage data which is gathered by the web analysis services used by us, like Google Analytics and HubSpot. You can find more information about this in Points 6, 7, and 8, below.

Apart from the use of our Website for purely information purposes, we offer different services which you can use if you are interested and for which you have the personal option to voluntarily disclose your Personal Data in order to utilise our services. ### 3. Why We Collect Personal Data

3.1 We may use your Personal Data or information for any of the following purposes:

- to enable you and us to customize or personalize your experience of our website;
- to enable you to access and use our website, associated applications and associated social media platforms;
- to contact and communicate with you;
- for internal record keeping and administrative purposes;
- for analytics, market research and business development, including to operate and improve our website, associated applications and associated social media platforms;
- to run campaigns and/or offer additional benefits to you;

- for advertising and marketing, including to send you promotional information about our products and services and information about third parties that we consider may be of interest to you;
- to solicit your opinion or feedback on products and/or services provided;
- to manage your newsletter subscriptions; and
- to comply with our legal obligations and resolve any disputes that we may have.

#### 4. Disclosure of your Personal Data

We may disclose your Personal Data or information to the following entities only to the extent the same is required for us to provide you services on our behalf:

##### 4.2 Business Partners

We also may disclose your information to entities that provide services for or on behalf of us, such as companies that run service centres, maintain this Website, to perform data integrity checks, to provide website optimisation services, to deliver advertisements on this Website, to send mail or email, and/or to provide customer service. These entities are limited in their ability to use your information for purposes other than providing services for us and are required by contract to use any information we share with them only to perform services to us or on our behalf and to protect the confidentiality of your Personal Data or information.

##### 4.3 Other Parties

There may be instances when we disclose your information to other parties:

- to comply with the law or respond to compulsory legal process (e.g. court orders or enforcement authorities);
- to verify or enforce compliance with the policies governing our services;
- to protect our rights and property or any of our respective affiliates, business partners, or customers;
- as part of a merger or transfer, or in the event of a bankruptcy; and
- when you consent to or request such sharing.

When we disclose your Personal Data to our affiliates, business partners, and other parties, this will mean that your Personal Data may be transferred to countries outside Taiwan, which have no comparable level of data protection so that an appropriate protection level is not guaranteed.

If this is the case, we ensure that data protection is sufficiently guaranteed. This is possible through binding company rules, standard contractual terms on the protection of personal data, certificates, or recognized codes of conduct. #### 5. Use of Cookies

Cookies are required to use the Balluff website. A cookie is a small file that can be stored on your computer when you visit a website. Every time you load our website, your browser checks if a cookie associated with our website exists (i.e. contains the name of our website). If it does, your browser sends the information saved in this cookie back to our website. This allows our website to recognize that it had already been opened in this browser before, and some of the displayed content may vary based on this information.

Cookies are generally stored in order to optimize and personalize page design, offer users additional features, increase loading speed, and for statistical purposes. With the use of cookies, we furthermore can offer you products and services that we think may be of interest to you. You can block or delete the cookies from this site. However, this action can prevent some of the website features from working properly.

Please note: None of the cookies used on our website collect information that can be used to identify you personally.

You can block or delete cookies in the browser settings. In order to manage cookies, most browsers allow you to accept or reject all cookies, or to accept only specific types of cookies. You can also adjust your settings so you will be asked every time a website wants to store a cookie. The ways in which you can specifically manage and delete cookies depend on your particular browser. Every browser differs in this respect. We use the following types of cookies, whose scope and operating principle are explained below:

- transient cookies (see 5.1)
- persistent cookies (see 5.2)

##### 5.1 Transient cookies

Transient cookies are automatically deleted when you close the browser. They include, in particular, session cookies. They save a session ID which can be used to assign different queries from your browser to the joint session. As a result, your computer can be recognized when you return to our website. The session cookies are deleted when you log out or close the browser.

##### 5.2 Persistent cookies

Persistent cookies are automatically deleted after a specified time which may vary depending on the cookie. You can delete the cookies in the security settings of your browser at any time.

You can configure your browser setting according to your wishes and refuse the acceptance of third-party cookies or all cookies. Click on the 'HELP' feature in your browser if you want to find out more about this.

Please note that you may not be able to use all features on the Website if you block or delete cookies.

We use cookies in order to be able to identify you for subsequent visits if you have an account with us. Otherwise, you have to log in each time you visit our Website.

The flash cookies used are not collected by your browser, but by your flash plug-in. We also use HTML5 storage objects that are placed on your end device. These objects store the necessary data irrespective of the browser used by you and

have no automatic expiration date. If you do not want to allow the processing of flash cookies, you have to install a corresponding add-on, e.g. BetterPrivacy for Mozilla Firefox or the Adobe Flash Killer Cookie for Google Chrome. You can prevent the use of HTML5 storage objects by setting your browser to privacy mode. We also recommend you manually delete your cookies and the browser history on a regular basis.

## Necessary Cookies

We use the HubSpot marketing automation software of the American company HubSpot Inc., 2nd Floor 30 North Wall Quay, Dublin 1, Ireland (hereinafter referred to as "HubSpot") for both our website [www.balluff.com.tw](http://www.balluff.com.tw), our blog [blog.innovatingautomation.asia/](http://blog.innovatingautomation.asia/) and our knowledge base [kb.innovatingautomation.asia/](http://kb.innovatingautomation.asia/). HubSpot is an integrated software solution by which we cover different aspects of our digital marketing, sales, and customer relation management. Furthermore, we use the tool for analytical purposes of our web offer to optimize it and to offer you the best possible and user-friendly service. We use HubSpot for:

- Contacting us through the contact form or live-chat box
- Sending newsletters
- Content management for our blog
- Subscription to blog updates
- Creating landing pages which are used as part of an advertising campaign and contain interaction possibilities such as contacting or download of white papers
- Social media linking and social media sharing
- Evaluating the usage of our web pages (e.g. access, pages visited, dwelling time, etc.) as well as for evaluating the usage of our newsletter (opening rate, click rate, unsubscribe, etc.)

Your personal data which you provide, e.g. when using our contact form, live chat or download form, are stored on the servers of our software and hosting partner HubSpot located in the USA.

Please note that particularly in the case of transmission to the USA there is a risk that your data may be processed by US authorities for control and monitoring purposes and you may not be entitled to any legal remedies.

Of course, HubSpot also uses "cookies" which are saved on your computer and allow us to analyse your usage of the website. The information gathered by us (e.g. IP address, geographical location, type of browser, duration of the visit and pages viewed) is evaluated by HubSpot on our behalf so that we can generate reports on the visit and the pages viewed and can therefore improve our online presence. If you generally do not want HubSpot to record your activities on our website and our blog, you can opt-out in the cookie message appearing during the first visit to our pages.

### 6.1 Forms on landing pages and newsletter marketing

Our legitimate interest in processing your data is to communicate with you and to answer your inquiries in a fast way. If you provide us with your personal data using the contact form, these data are always disclosed on an explicitly voluntary basis.

The following data can be collected on a mandatory basis, when using the contact form, download form, or the live-chat box:

- Your first and last name, e-mail address, phone number, title (Mr./ Mrs.), job function, industry, company and country can be mandatory items to process your request and send you an answer. This means, in the contexts specified, that if you do not provide this information, then we cannot respond to you.

Technical data collected:

- IP address, Time of subscription and webform used for the subscription.

Your personal data will not be passed on to any unauthorized third parties. The data is stored in our marketing automation tool HubSpot. Every newsletter contains an unsubscribe link. Furthermore, you can always send an e-mail to [DP.APAC@Balluff.com](mailto:DP.APAC@Balluff.com) and inform us to withdraw your consent to the processing of your data.

### 6.2 Blog and updates

You can register for a blog update with your e-mail address. This means that we send you e-mails with your preferred receiving frequency each month with posts from [blog.innovatingautomation.asia](http://blog.innovatingautomation.asia).

If you provide us with your personal data by subscribing to the blog update, these data are always disclosed on an explicitly voluntary basis. You always have the possibility to withdraw your consent to the processing of your data via e-mail to us at [DP.APAC@Balluff.com](mailto:DP.APAC@Balluff.com).

### 6.3 Netigate

This can be completed on a voluntary basis. By clicking "Finish", it will be deemed that you have given your explicit and separate consent to us Balluff to collect, process, share, and store your personal information that you filled in for the purposes mentioned in our Privacy Statement. You have the right to refuse or withdraw your consent at any time by contacting us. Please note that if you choose to refuse or withdraw your consent, we might not be able to provide you with relevant services. After the checkout we will conduct an anonymous survey which is to be completed on a voluntary basis. This survey includes a satisfaction rating and a comments section. The aim is to further develop the online shop and improve customer satisfaction.

### 6.4 Newsletters

To keep you up to date about our company and products, we offer newsletters on different topics:

- Service E-Mails
- Industry News
- Balluff News (Company/ Marketing/ Application/ Products)
- Innovating Automation News
- Sales and Offer Emails
- Blog News

Only your e-mail address is required for sending the newsletters. The disclosure of other, separately marked data is voluntary and is used to be able to address you personally. You may revoke your consent at any time. This can be done by clicking on the link in every newsletter e-mail or sending an e-mail to [DP.APAC@Balluff.com](mailto:DP.APAC@Balluff.com).

For sending the newsletter we make use of HubSpot, who has been bound by us to comply with the data protection laws. Our e-mail newsletters may contain links which lead you to special Balluff websites. In this way we can measure the effectiveness of marketing initiatives. The newsletters may also contain links to third-party websites. After you unsubscribe, we shall block your data given in this context so that you no longer receive any newsletters from us in the future.

#### 6.5 Live Chat

If you want to receive direct information or help on our products, services, or other information about Balluff, you have the option to contact us directly and quickly via the Chat feature on our Website (at certain times). To take part in the live chat, we require your name, e-mail address and job function. If you share other Personal Data with us during the live chat, this information is provided on a voluntary basis.

#### 6.6 Analytical data and reporting

Using HubSpot we can carry out the following analytical collections and evaluations, among other things:

- Activity on our web pages and our blog
- Number of page views and dwelling time of website visitor
- Click path of the respective visitor
- Downloads of files provided via the website
- Visits to landing pages
- Opening rates of e-mails from newsletters and campaigns

By using the website or blog you declare your consent to the collection of analytical data. You can always unsubscribe from the HubSpot tracking using the opt-out button in the cookie message.

#### 6.7 HubSpot logfiles

Whenever calling up websites/landing pages created using HubSpot, HubSpot automatically generates so-called logfiles. Among other things, the logfiles can contain the following information: IP address, browser type, domain names, internet service provider (ISP), the files viewed on our site (e.g., HTML pages, graphics, etc.), operating system, clickstream data, access times and referring website addresses. This information is used by HubSpot to provide general statistics regarding use of the Websites. For these purposes, we do link this automatically-collected data to other Personal Information such as name, email address, address, and phone number.

### 7. Use of Google Analytics

This Website uses Google Analytics, a web analysis service of Google Inc. (Google), which uses cookies. The information generated by the cookie about your usage of this Website is generally transferred to a Google server in the USA and stored there. Upon activation of the IP anonymization on this Website, your IP address may be shortened beforehand by Google. Google shall use this information on behalf of the operator of this Website in order to evaluate your usage of the Website, compile reports about the Website activities, and to provide further services to the Website operator associated with the Website and Internet usage.

We use Google Analytics in order to be able to analyse and regularly improve the usage of our Website. This Website uses Google Analytics with the extension "anonymizelp()". The IP address transferred by your browser within the framework of Google Analytics is not merged with other data of Google. We use Google Analytics in the form of "Universal Analytics". "Universal Analytics" describes a procedure of Google Analytics where the user analysis is effected on the basis of a pseudonym user ID and thus a pseudonymous user profile is created with information from the usage of different devices (commonly known as "Cross Device Tracking").

## 9.2 Google Adwords Conversion

We also use the heatmap & session recording modules. Matomo's heatmap service shows us the areas of our website where the mouse is most often moved or clicked. The session recording service records individual user sessions. We can replay recorded sessions and thus analyze the use of our website.

Data entered in forms is not recorded and is not visible at any time. Your IP address is anonymized immediately after processing and before it is stored.

You can configure your browser settings according to your wishes and refuse the acceptance of such cookie. If you have given your consent via our banner. You can revoke your consent at any time.
